  - B. Black belt: 106 CNY for print, 136 CNY for embroidery;
  - C. Instructor: 116 CNY for print, 150 CNY for embroideryNote: this price is valid since 1st Jul. 2018.

## 2. Delivery and freight charge

Considering the different needs of customs clearance in each country, we suggest buyers to select their own freight forwarders for delivery and clearance. For those who are not able to find the appropriate forwarders, China ITF will assist to contact with the agents within China.

The freight charge will be calculated according to the order, the destination, and date of delivery. Please contact with China ITF by emails.

## 3. Date of delivery

China ITF will hand over the dobok to the forwarder of the buyer or assist the buyer to find the appropriate freight forwarder and send the doboks out of China within 30 days for less than 1000-suit-order or 45 days for less than 2000-suit-order since the date of finishing exchange settlement.

The arrival time of the order varies according to the method of transportation. Please contact with China ITF by emails.

## 5. Procedure of purchase

- (1) The buyer shall inquire with China ITF by emails;
- (2) Both the parties shall sign the contract, and seller shall send the proforma invoice to the buyer for payment;
- (3) The buyer shall pay for the order. For safety purpose, the buyer is highly suggested to make phone call with the seller to confirm the bank account information.
- (4) After the exchange is settled, the seller shall arrange for production;
- (5) The seller shall hand over the order to the freight forwarder of the buyer or assist the buyer to find the appropriate forwarder to send the order out of China within 30/45 days since the date of finishing the exchange settlement.
- (6) Order receipt confirmation.
